Application

Palouse Properties thanks you for selecting us for assistance with your residential housing needs. The owners and tenants of the properties we manage include our neighbors, families, and friends. We feel an obligation, therefore, to ensure that properties managed by Palouse Properties are rented and maintained in a manner that protects the quality of both the dwellings and the neighborhoods where our tenants reside. For this reason, Palouse Properties utilizes a thorough screening process of all tenant applications based, in part, on the set of objective criteria listed below.

Once you have selected a rental, you must complete, sign and return the Application. Each person over the age of 18 years who intends to reside in the rental unit must submit an Application. In order for an applicant to be considered for tenancy, the applicant must meet the following minimum requirements. These requirements are not the exclusive criteria on which a decision will be based. Palouse Properties reserves the right to use its managerial discretion in reviewing each application.

- **1. Age and Identification** All rental applicants must be over the age of 18 years, have a valid government issued picture identification and a social security number. Foreign nationals must provide a valid passport and visa information (form I-20, or other visa documents).
- **2. Complete application** A Palouse Properties rental application must be completed in its entirety. Failure to complete the entire application or submission of false information will result in denial of the application.
- **3. Verifiable Good Credit** Credit reports from a national credit bureau will be examined. Seventy-five percent of the credit items that appear on the report must be rated seven or lower on a 0 to 9 scale.
- **4. Good Previous Rental History** Applicant's previous landlords must give positive recommendations to Palouse Properties survey.
- **5. Criminal History** No applicant will be accepted who has been convicted of a felony and has not successfully completed all aspects of the sentence, including incarceration, probation and restitution. The completion date of all aspects must be at least seven years ago. No applicant will be accepted who has been convicted or plead no contest to a crime of person or property, sex crime, or is a registered sex offender.

Palouse Properties cannot guarantee any unit you have seen to be available by the time your application is processed. There is no agreement to rent a particular property until the lease agreement is signed by both lessee and lessor. The security deposit must be paid in full at the time the lease is signed.

Please be aware that only select properties allow pets. The presence of unauthorized pets in the dwelling units, even temporarily, is grounds for collection of additional fees and/or immediate termination of the lease under our standard Rental Agreement.
